## ARTICLES OF INCORPORATION

### ARTICLE I

The name of the Corporation is MONEY MAKERS, INC.

### ARTICLE II

The Corporation shall have perpetual existance. The date and time of commencement of Corporation existance shall be as of the filing of the Articles of Incorporation by the Department of State, State of Florida.

The number of Directors shall not be less than (1) nor more than (2).
