ARTICLE I

The name of the Corporation is MONEY SAVERS, INC.

ARTICLE II

The Corporation shall have perpetual existence. The date and time of commencement of Corporation existence shall be as of the filing of the Articles of Incorporation by the Department of State, State of Florida.

ARTICLE III

The general purpose of which the Corporation is initially organized is the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

The number of Directors shall not be less than (1) nor more than (2).

Each Director shall hold office for a term of one (1) year or until his successor shall have been elected, or until his earlier resignation, removal from office, or death.
