Dear Sir/Madam,

This is a plea for forgiveness of penalty. I realize it is my responsibility to send in my payment on time - even though I did not receive a form or reminder.

This company is run only by myself with help from my wife. I make a living working for someone else as we try to make this company go. It is the first time we have ever tried to start a corporation and the number of things one must remember to do is sometimes a burden.

As soon as we discovered we were past the deadline I called my registered agent which is a law firm. They talked to a state agent and told me that not only did the corp. owe the annual fee, but that there is a late fee bringing the total to \$550! The company has no money and will have to get a loan from me to pay this debit.

The lawyers also told me that one of your agents told them that one or more clients could send their payment without the late fee even though it was a day or so past due. I would like to claim the same privilege and only pay the \$165.

Please don't charge the late fee and accept the \$165 as full payment. My wife and I promise to be more diligent in the future.
