ARTICLES OF INCORPORATION  
OF  
NETWORKING REFERRAL SERVICES, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is "Networking Referral Services, Inc." Its place of business and mailing address is 1371 Gimlet Street NW, Palm Bay, FL 32907.

The duration of this corporation is to be perpetual.

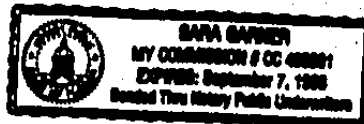
