



ARTICLE I - JET EXPRESS TRANSPORT, INC.

The name of this corporation is JET EXPRESS TRANSPORT,
INC.

ARTICLE II - PURPOSES

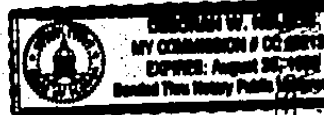
