ARTICLES OF INCORPORATION OF AMELIA ISLAND TRANSPORTATION, INC.

ALCONING PH 1:03

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: AMELIA ISLAND TRANSPORTATION, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be: 2364 JAMESTOWN RD., FERNANDINA BEACH, FL 32034

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE IV - PURPOSE
