## ARTICLE OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF MARINE BANK & TRUST COMPANY

Pursuant to the provisions of Sections 607.1002, 607.1006, and 658.23 Florida Statutes; Marine Bank & Trust Company (the "Bank") hereby adopts the following Article of Amendment 11.0 to the Bank's Amended and Restated Articles of Incorporation, dated April 30, 2001, as subsequently amended.

Article IV(A) of the Amended and Restated Articles of Incorporation, as amended, is hereby amended in its entirety to read:

### A. Number and Class of Shares Authorized; Par Value.

The total number of shares authorized to be issued by the Corporation shall be: (a) 100,000,000 shares of common stock, with a par value of \$1.50 per share; and (b) 5,000,000 shares of preferred stock, with a par value of \$5.00 per share.

The remainder of the Articles of Incorporation shall remain unchanged.

In accordance with Sections 607.1002, Florida Statutes, the foregoing Article of Amendment was proposed and approved by the Board of Directors of the Corporation at a duly called meeting of the Board of Directors on December 19, 2013. Approval of the Corporation's shareholders was not required in accordance with Section 607.1002, Florida Statutes.
