## ARTICLES OF AMENDMENT

OF

# LEVITZ FURNITURE REALTY CORPORATION

(BY SOLE INCORPORATOR)

PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT.

FIRST: THE NAME OF THE CORPORATION IS LEVITZ FURNITURE REALTY CORPORATION.

SECOND: THE ARTICLES OF INCORPORATION OF THIS CORPORATION ARE AMENDED BY CHANGING THE ARTICLE NUMBERED "SEVENTH" SO THAT, AS AMENDED, SAID ARTICLE SHALL READ AS FOLLOWS:

- (1) The corporation is formed solely for the purpose of (a) acquiring and holding certain leasehold interests in real property occupied by Levitz Furniture Corporation in connection with the retail operations of Levitz Furniture Corporation (the "Leases") and (b) to engage in such other activities as may be necessary, incidental or desirable to accomplish the foregoing; provided, however, that notwithstanding anything to the contrary herein, so long as the stock of the corporation shall be pledged to secure indebtedness for money borrowed, the corporation shall have no power (without the consent of the holders of such indebtedness) to
- (i) carry on any trade or business (other than as may be incidental to the acquisition and ownership of the Leases);
- (ii) incur indebtedness for money borrowed (including, without limitation, by way of assumption, directly or by guaranty, or otherwise);
- (iii) engage in any dissolution, liquidation, consolidation, merger, asset purchase or asset sale (other than acquisition or disposition of Leases in the ordinary course of the business of Levitz Furniture Corporation and its subsidiaries); or

- (iv) amend this Certificate of Incorporation in any material respect.
  - (2) The corporation shall:
- (a) maintain books and records separate from any other person or entity;
- (b) maintain its accounts separate from any other person or entity;
- (c) not commingle assets with those of any other entity;
  - (d) conduct its own business in its own name;
  - (e) maintain separate financial statements;
- (f) observe all formalities of a corporation organized under the laws of the State of Florida;
- (g) allocate fairly and reasonably any overhead for office space shared with any entity;
- (h) use separate stationery, invoices and checks;
  - (i) hold itself out as a separate entity;
- (j) correct any known misunderstanding regarding its separate identity;
- (k) maintain adequate capital in light of its contemplated business operations; and
- (1) pay its own liabilities from its own separate assets.

THIRD: THE AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE CORPORATION SET FORTH ABOVE WAS ADOPTED ON THE 41% DAY OF NOVEMBER, 1996.

FOURTH: PRIOR TO THE ISSUANCE OF SHARES, THE AMEND-MENT WAS ADOPTED BY THE SOLE INCORPORATOR AND SHAREHOLDER ACTION WAS NOT REQUIRED.
