The undersigned, acting as incorporator of ALONDRA MANAGEMENT GROUP, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is ALONDRA MANAGEMENT GROUP, INC.
