

## ARTICLES OF AMENDMENT TO THE 2013 JAN 14 PM 4: 42

MELBY & GUARINO, CPA'S, P.A. TALLAHASSEE. FLORIDA

Melby & Guarino, C.P.A.'s, P.A., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), under the hand of its undersigned Director and pursuant to §607.1006, Florida Statutes, hereby certifies that on January 10, 2013, the Board of Directors of said Corporation signed a written statement, duly adopting and approving an amendment to the Articles of Incorporation of the Corporation as hereinafter set forth.

1. <u>Amendment to Name and Mailing Address</u>. The Articles of Incorporation of the Corporation are amended by deleting Article I thereof, in its entirety, and by substituting therefor the following:
