THE UNDERSIGNED, acting as sole incorporator of **SOUTH LAKE MOBILE HOMES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be **SOUTH LAKE MOBILE HOMES, INC.**

ARTICLE II

Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

ARTICLE III

Principal Office

The address of the Principal Office of the corporation 17720 Highway 27, Clermont, FL 34711. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the corporation.

ARTICLE IV

Initial Board of Directors


The number of Directors constituting the initial Board of Directors of the corporation is two. The person who is to serve as initial Director until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify is Robert L. Hall and Walter L. Marquis.

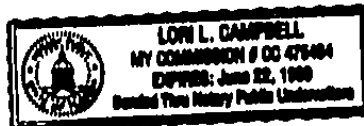
