OF

THE UNDERSIGNED SUBSCRIBER to these articles of Incorporation
a natural person competent to contract, hereby forms a
corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is:

GUYCO DEVELOPERS INC.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted by
this corporation is:

a) To engage in every aspect and phase of the business of






