ARTICLES OF INCORPORATION
OF
WOMBLE ENTERPRISES, INC.

The undersigned, subscriber(s), natural person(s) competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts, the following Articles of Incorporation for such corporation.

ARTICLE ONE - NAME

The name of the proposed corporation is WOMBLE ENTERPRISES, INC. The address of the Corporation is 1295A-Carlton Arms Cir., Bradenton, Florida 34208.

ARTICLE TWO - NATURE OF BUSINESS

The corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida, and all acts or statutes amendatory thereof and supplemental thereto.

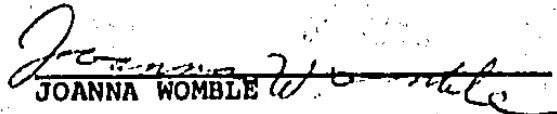

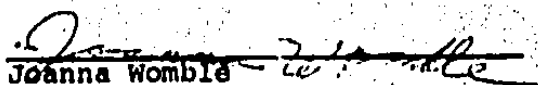
