Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

**FIRST:** Article One of the Articles of Incorporation states the following:

“The name of the corporation that satisfies the requirements of section 607.0401 is:  
Princeton Medical Management Resources of Florida, Inc.”

Article One of the Articles of Incorporation is amended to change the name of the corporation to:

“Wellmed Medical Management of Florida, Inc.”
