ARTICLES OF INCORPORATION

OF BIGIO PRODUCTIONS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation is BIGIO PRODUCTIONS, INC.

ARTICLE IL

DURATION AND BEGINNING OF CORPORATE EXISTENCE
