ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is SPECTRUM INTERNATIONAL MORTGAGE SERVICE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - INITIAL MAILING ADDRESS

ARTICLE IV - PURPOSE


