ARTICLES OF INCORPORATION OF 96 SEP 27 MII0: 16

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is Stevens R.V. Resorts, Inc. The principal office, if known, or the mailing address of the Corporation is 5775 - 22nd Avenue Southwest, Naples, Florida 34116.
