THE UNDERSIGNED incorporator, for purposes of forming a Florida professional service corporation under the Professional Service Corporation Act (Florida Statutes, Chapter 621), hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the corporation is Comprehensive Osteopathic Medical Specialists, P.A. (the "Corporation").
- SECOND:** The principal office address and mailing address of the Corporation is 21110 Biscayne Boulevard, Suite 206, North Miami Beach, Florida 33180.
- THIRD:** The Corporation is authorized to issue 10,000 shares of common stock, par value \$.01 per share.
- FOURTH:** The street address of the initial registered office of the Corporation is: 1201 East Lake Drive, Ft. Lauderdale, Florida 33318, and the registered agent at that address is: Richard M. Herschelman.
- FIFTH:** The name and address of the incorporator of the Corporation is: Barry M. Blumenthal, D.O., 21110 Biscayne Boulevard, Suite 206, North Miami Beach, Florida 33180.
- SIXTH:** The Corporation, through its officers and employees, shall be authorized to: (i) engage in the provision of medical services pursuant to the licenses which such officers and employees have obtained from the State of Florida; (ii) to engage in any activities which will facilitate and promote the provision of such medical services through the Corporation's officers and employees; (iii) to invest the Corporation's funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of Florida Statutes Section 621.08 of the Professional Service Corporation Act; and (iv) purchase and own real and personal property necessary for the rendering of medical services. The Corporation shall not be authorized to engage in any business other than the provision of medical services.
