

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **ORLANDO PRIMARY CARE, P.A.**, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ORLANDO PRIMARY CARE, P.A.
2. The original Articles of Incorporation for the corporation were filed on September 30, 1996, and assigned Charter No. P96000081028.
3. By written consent executed on April 11, 2003, by the sole shareholder and sole director, respectively, the sole shareholder and sole director have approved, authorized and directed that the Articles of Incorporation shall be amended to change the name of the corporation to "THE FLORIDA LIPID INSTITUTE, P.A."
