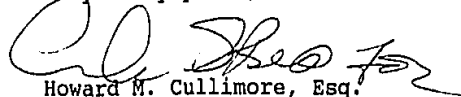

The name of the incorporator to these articles of incorporation is George Davies, 307 Tuckhoe Road, Yonkers, NY 10710.

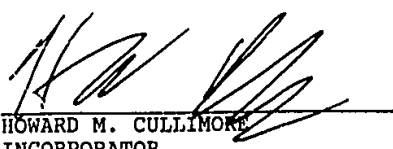
**ARTICLE SEVEN**

**CERTIFICATE OF DESIGNATION**

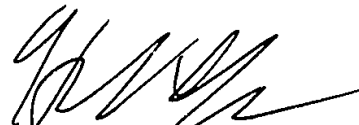
**REGISTERED AGENT AND REGISTERED OFFICE**
