**ARTICLES OF INCORPORATION  
OF  
STRICKLAND FAMILY CORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be Strickland Family Corporation.

**ARTICLE II PRINCIPAL OFFICE**


**ARTICLE VII INDEMNIFICATION**

The directors or shareholders of this Corporation may take action by written consent as provided by law.


