ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is D & A PROPERTIES, INC., and the principal address and principal place of business is 6204 Armenia Avenue, Tampa, Florida.

ARTICLE II - REGISTERED OFFICE AND AGENT
