I received my first Annual report filing notice just recently, and then discovered that the filing fee had gone from \$165 to \$750. I can afford \$165 from my own funds which deposit regularly from my Military retirement pay, but there is no way I can afford \$750.


The problems are many: 1. I am used to the word "Annual Report" to describe a year which would be ended either on the anniversary of formation, or the end of a calandar year, with a period of time allowed for preparation and submission.

2. My Current Registered Agent, Mr Joseph R. Locker would have some responsibility of notification to requirements after having paid him, and find that he is not longer a member of the Bar.

3. I received a bill for \$165 for a Corporation called SAMMB from a company called CSC, which seemed to be a scam, but I am now my own current registered agent (Incls 2, 3, 4 and 5)
