Indemnification



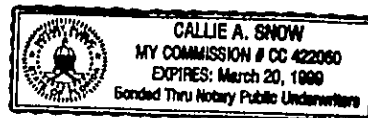
