ARTICLES OF INCORPORATION OF FULLER-WARREN CHARTER SERVICES, INC.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to from a corporation for profit under the laws of the state of Florida.

ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - BUSINESS AND ACTIVITIES

This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the state of Florida in connection with the ownership, operation and charter of vessels in the coastwise trade.

ARTICLES III - CAPITAL STOCK

The authorized capital stock of this corporation and the maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having par value of \$1.00 per share.

- A. The initial number of directors of this corporation shall be one (1).
- B. The number of directors may be either increased or diminished from time to time by the board of directors or the shareholders in accordance with the bylaws of this corporation.
- C. Directors, as such, shall receive such compensation for their services, if any, as may be set by the board of directors at any annual or special meeting thereof. The board of directors may authorize and require the payment of reasonable expenses incurred by directors in attending meetings of the board of directors.

- D. Nothing in this article shall be construed to preclude the directors from serving the corporation in any other capacity and receiving compensation therefor.
