**ARTICLES OF INCORPORATION
OF
ALTERNATIVE MARKETING STRATEGIES, INC.**

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a Florida corporation ("corporation"), pursuant to Chapter 607, Florida Statutes.

ARTICLE I

NAME: The name of this corporation shall be "Alternative Marketing Strategies, Inc."

ARTICLE II

STREET ADDRESS: The street address of the principal office of this corporation is 2700 North Peninsula Avenue, #231, New Smyrna Beach, FL 32169.

MAILING ADDRESS: The mailing address for this corporation is P.O. Box 3302, New Smyrna Beach, FL 32170.

ARTICLE III

NATURE OF BUSINESS: This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

CAPITAL STOCK: This corporation is authorized to issue 100 shares of common stock at a value of \$1.00 per share. The issuance and transfer of the corporation's stock shall be in accordance with Chapter 607, Florida Statutes. The owner or owners of said shares of common stock shall have unlimited voting rights, shall be entitled to receive dividends as declared by the corporation, and shall be entitled to receive the net assets of the corporation upon dissolution.

ARTICLE V

TERM OF EXISTENCE: This corporation shall have perpetual existence.

ARTICLE VI

ARTICLE VII

BOARD OF DIRECTORS: The initial Board of Directors shall consist of one (1) member, who need not be a resident of the State of Florida or a shareholder of the corporation.

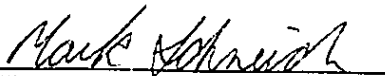
ARTICLE X
