The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **USA RECAMBIOS MARINOS CORP.**, (hereinafter, "Corporation"). The english translation of this corporation name is "USA Marine Spare Parts, Inc."

ARTICLE 2 - PURPOSE OF CORPORATION
