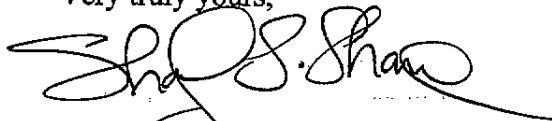

ARTICLES OF DISSOLUTION

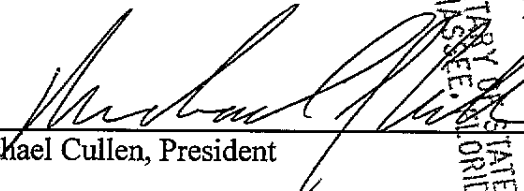
Pursuant to Section 607.1403 of the Florida Statutes, this Florida profit corporation submits the following articles of dissolution:
