**ARTICLES OF INCORPORATION  
OF  
STUART CABINET WORKS, INC.**

**ARTICLE I - NAME**

The name of this corporation is Stuart Cabinet Works, Inc.

**ARTICLE II - ADDRESS**

The street address of the initial principal office of the corporation is 2409 SE Dixie Highway, Stuart, Florida 34996, which is the mailing address of the corporation.

**ARTICLE III - CAPITAL STOCK**

This corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated as "common shares."

**ARTICLE IV - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE V - INITIAL OFFICES AND AGENT**

The street address of the corporation's initial registered office is 2409 SE Dixie Highway, Stuart, Florida 34996. The name of its initial registered agent at that office is Ethan Feeney.

**ARTICLE VI - INCORPORATOR**

The name and address of each incorporator signing these Articles is Ethan Feeney.

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

The corporation shall have two directors to hold office until successors shall have been duly elected and qualified, or until their earlier resignation, removal from office, or death. The number of directors may be either increased or decreased from time to time in accordance with the Bylaws of the corporation. The names and addresses of the initial directors are Ethan Feeney and Sarah Feeney, 3842 SW 42nd Ave., Palm City, Florida 34990.

#### **ARTICLE VIII - DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

#### **ARTICLE IX - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

#### **ARTICLE X - INDEMNIFICATION**

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### **ARTICLE XI - AMENDMENT**

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

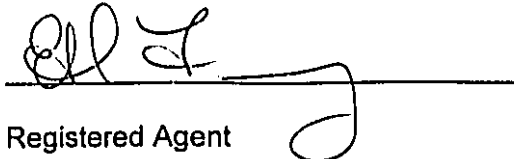
#### **ARTICLE XII - RESTRICTION ON TRANSFER**

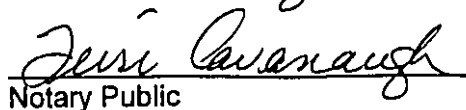
