ARTICLES OF INCORPORATION

OF

ACI ARCHITECTS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of this corporation is ACI ARCHITECTS, INC.

ARTICLE TWO

The corporation is to have perpetual existence.


