ARTICLES OF INCORPORATION OF SECURITY FIRST-WILL AND TRUST
STORAGE OF AMERICA, INCORPORATED

The incorporator forms a corporation under the Florida Business Corporation Act, adopting the following articles of incorporation:

1 NAME- The name of this corporation is SECURITY FIRST-WILL AND TRUST STORAGE OF AMERICA, INCORPORATED

2 PRINCIPAL OFFICE- The principal office of corporation is 121 1/2 North Woodland Boulevard, Suite six (6), DeLand, Florida 32720

3 TERM- This Corporation shall exist perpetually

5 CAPITAL STOCK- This corporation is authorized to issue one hundred (100) shares of common stock of a single class with a par value of five dollars (\$5.00) per share



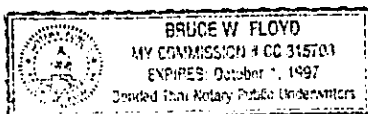
