ARTICLE I

Name

The name of the corporation is **ENVIRONMENTAL PLANTS CARE, INC.**, a Florida corporation.

ARTICLE II

Duration

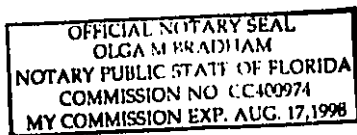

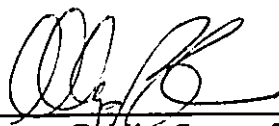
