ARTICLE I.

CORPORATE NAME

The name of this corporation shall be: C & EX INTERNATIONAL, Inc.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III.

CAPITAL STOCK






