Dear Ms Ashton:

First, I want to thank you and your supervisor for being so patient, caring, and understanding during our recent phone discussion regarding this matter.

On October 7, 2008 we received your Letters numbered 708A00052097 and #408A00052099 with "Reinstatement" Application form for our corporations, Foxtech International, Inc. and Dontech, Inc., respectfully. I have enclosed the form for Foxtech and the form for Dontech, Inc., together with a check in the amount of \$158.75 for each corporation, which checks are for the filing fees and Certificates of Status..

Per our phone discussion I am requesting that any and all reinstatement fees and/or penalties be waived. You advised that I should reiterate the circumstances and reasons I had discussed with you as to why the Reinstatement fees and any other fees should be abated. These circumstances are as follows:

On or about January 11, 2008 we received cards from your office regarding the filing of the Corporate Annual Reports for Foxtech International, Inc., and Dontech, Inc. for the year 2008. The cards explained the use of computers to file and/or to return the self addressed bottom portion requesting copies of the return be mailed for our completion and filing. On January 14, 2008 we mailed the bottom portion of each card requesting that forms be sent to us for preparation and filing, as we had in prior years.

In April 2008 we contacted your office and inquired the status of the forms we requested, as we had not received them. We were advised that our request was in progress and we should soon receive the returns. We waited for the requested forms which never came nor did we hear from your agency.

In July, while preparing our quarterly tax returns and reports, we remembered that we never received the requested Corporate Annual Report forms from your Agency and therefore had not filed. I again phoned your agency office and explained our situation with the representative, and requested Forms so we could file the Reports. I was advised that no returns were sent as we were to file Online with our computers; that hard copies of the Forms were not sent. It was admitted that filing by computer was a request of the agency and there was no mandatory requirement that a computer filing had to be made of these reports. The final conclusion of this phone discussion with your representative was that the matter would be looked into and we would be advised. I had explained to the representative that due to the highly sensitive nature of the documents we process and our workproduct, and the constant attempt of "Hackers" to invade our computer hard drives, we do not utilize the Online facilities. I advised that until it was mandatory that we file Online with our computers, we will opt to obtain hard copies of the form and file as we always have.


On August 9, 2008 we received a card for each corporation labeled "Notice of Intent to Dissolve". These cards explained the use of computers for filing the Annual Reports. We immediately returned via mail the bottom half of each card requesting that we had requested hard copies of the Annual Report forms and had not received them as yet. That we were waiting for the return forms so we could file. We never heard from your office and never received the forms.

We were out of state during the months of August through September 26, 2008. When there had been no Return forms received and no calls listed from your office thru that date, on September 30, 2008 I again phoned your agency. I spoke to Ms Ashton who patiently listened to me and discussed this matter with me recommending what should be done. On September 30 Ms Ashton sent us the letters and forms which we received and have enclosed with this Return. This is the first correspondence and forms your office has sent us since we requested the forms on January 14, 2008

If your agency had timely furnished us with the Forms we originally requested on January 14, 2008 in response to your cards received on January 11,, 2008, or in response to our phone requests, the Reports would have been timely filed. I have been advised that the Report /Returns Forms are available only directly through your Agency.

Thanks again. Sorry for any inconvenience. Kindly advise me.
