ARTICLES OF INCORPORATION OF ST Telecom Corp.

96 OCT LED TALLAHASSE OF SIL

The undersigned incorporator, for the purpose of forming a corporation under the Florida, Business Corporation Act, hereby adopt the following Articles of Incorporation:

I. Name.

The name of the Corporation is ST Telecom Corp.

2. Principal Office and Registered Agent.

lts registered office in the State of Florida is 2001-A Australian Avenue, in the City of Riviera Beach, County of Palm Beach. The name of its registered agent at such address is Darrell L. Peterson.

3. Purposes.

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida.

4. Capital Stock,

The total number of shares of capital stock that the Corporation shall have authority to issue is 100, all of which are to be common stock with par value of one dollar (\$1.00) per share.

5. Incorporator.

8. Management.

Subject to the provisions of the laws of the State of Florida, the following provisions are adopted for the management of the business and for the conduct of the affairs of the Corporation, and for

- (g) Upon any sale, exchange or other disposal of the property and/or assets of the Corporation, payment therefor may be made either to the Corporation or directly to the stockholders in proportion to their interests, upon the surrender of their respective stock certificates, or otherwise, as the Board of Directors may determine.
- (h) In case the Corporation shall enter into any contract or transact any business with one or more of its directors, or with any firm of which any director is a member, or with any corporation or association of which any director is a stockholder, director or officer, such contract or transaction shall not be invalidated or in any way affected by the fact that such director has or may have an interest therein which is or might be adverse to the interests of the Corporation, even though the vote of such director might have been necessary to obligate the Corporate upon such contract or transaction; provided, that the fact of such interest shall have

been disclosed to the other directors or the stockholders of the Corporation, as the case may be, acting upon or with reference to such contract or transaction.
