ARTICLES OF INCORPORATION OF ELM TREE CAPITAL CORP.

The undersigned, desiring to form a corporation (the "Corporation") under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of the Corporation is Elm Tree Capital Corp.

ARTICLE II PURPOSE
