**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under Florida General Corporation Act, hereby adopts the following articles of incorporation:

**ARTICLE I**

The name of the corporation shall be Able Lawn Care, Inc., hereinafter referred to as the "corporation."

**ARTICLE II**

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE III**

This corporation shall have all such powers as may be permissible to corporations under the laws of the State of Florida, and all powers necessary or desirable to accomplish the purposes and business of the corporation as hereinabove set forth in Article II.

**ARTICLE IV**

This corporation has the authority to issue two hundred (200) shares of common stock with a par value of One Dollar (\$1.00) per share.

**ARTICLE V**

This corporation is to exist perpetually.

#### ARTICLE VI

The initial street address of the principal office of this corporation in the state of Florida is 849 Dempsey Avenue, Sebastian, Florida 32958. The board of directors may from time to time move the principal office to any other address in Florida.

#### ARTICLE VII

This corporation shall have one (1) director, initially. The number of directors may be increased or diminished from time to time as provided in the by-laws.

#### ARTICLE VIII


