THE UNDERSIGNED incorporator hereby makes, subscribes acknowledges, and files with the Department of State these Articles of Incorporation for the purpose of forming a corporation for the profit in accordance with the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be as stated above and its business shall be carried on in the State of Florida, and in the United States of America and elsewhere, as may be authorized by the Board of Directors.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

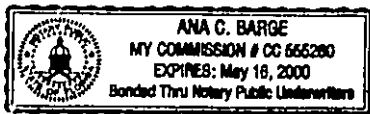

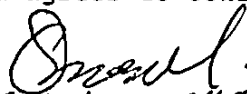
