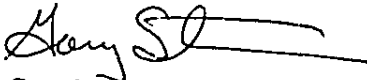

Article I - Name

The name of this corporation is Capt. Gary's Services, Inc.

EFFECTIVE DATE

10-1-96

Article II - Duration

The corporation shall have a perpetual existence and shall be effective October 1, 1996.

Article III - Purpose

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States of America and Florida.

Article IV - Capitol Stock

The maximum number of shares which this corporation is authorized to have outstanding at any time is 100 shares of common stock, having a par value of \$10.00 per share.

Article V - Initial Registered Office and Agent

Article VI - Initial Board of Directors/Officers

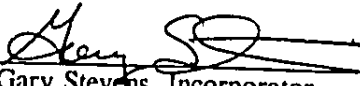
