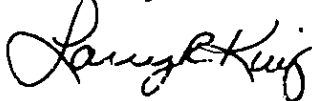

OF

**ARTICLE I-NAME**

The name of this corporation is Westec Development, Inc.

**EFFECTIVE DATE**  
10-2-96

**ARTICLE II-DURATION**

This corporation shall exist perpetually, commencing on October 2, 1996.

**ARTICLE III-PURPOSE**

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the State of Florida.

**ARTICLE IV-CAPITAL STOCK**

This corporation is authorized to issue 500 shares of par value common stock.

**ARTICLE V-PRE-EMPTIVE RIGHTS**

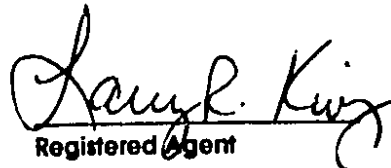
