ARTICLE I - NAME

The name of this corporation is Mulberry Copy Center, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - COMMENCEMENT OF CORPORATE BUSINESS

In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial principle office of this corporation is 305 N. Church Ave. Unit - B, Mulberry, FL. 33860 and the name and street address of the initial registered agent is Joni L. Long, 504 N.W. 1st Ave. Mulberry, FL. 33860

ARTICLE VI - ADDRESS OF PRINCIPLE OFFICE

The mailing address for this corporation is 305 N. Church Ave. Unit - B, Mulberry, FL. 33860.

ARTICLE VII - INCORPORATOR

The incorporator of this corporation is Joni L. Long. The business address is 305 N. Church Ave. - Unit B, Mulberry, FL. 33860

ARTICLE VIII CAPITAL STOCK

Number. The aggregate number of shares that the corporation shall have the authority to issue is 1000 shares of Capital Stock with a value of \$ 1.00 per share.

Initial Issue. One hundred (100) shares of the Capital Stock of the corporation shall be issued for cash value of one dollar (\$1.00) per share.

Stated Capital. The sum of the value of all shares of Capital Stock of the

corporation that have been issued shall be the stated capital of the corporation at any particular time.

In the event any transfer, encumbrance, or distribution of stock of the corporation under this Article creates an equal division of stock between two shareholders or shareholder factions, and any voting deadlock occurs, the President of the corporation or the person acting in the Presidents capacity, shall cause the corporation to issue one share of stock to a person acceptable to the two equal shareholders or shareholder factions, or failing agreement, to the corporation's resident agent, so that the ability of the corporation to exist or operate shall not be impaired, and that dissolution may be avoided. It is intended that this stock qualify for Code Sec. 1244 treatment under the Internal Revenue Code.






