ARTICLES OF INCORPORATION OF
TROMBLEY'S AUTOMOTIVE CENTER, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article I

The name of this corporation is Trombley's Automotive Center, Inc. The principal office and mailing address of the corporation are: 2740 West State Road 46 (P.O.Box 902) Geneva, Florida 32732.

Article II

The corporation shall exist perpetually unless dissolved according to Florida law.
