## ARTICLES OF INCORPORATION OF WEIGHT REDUXING CONTROL, INC.

#### · ARTICLE I - NAME

The name of this Corporation is WEIGHT REDUXING CONTROL, INC.

#### ARTICLE II - DURATION ...

The corporation shall have perpetual existence commencing on the date of this filling of those Articles with the Department of State.

#### ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any or all lawful business for which corporation may be incorporated under Chapter 607, Florida Statutes, as now edits or may after be amended, and any other activities or business permitted under the Laws of the United States and Florida.

#### **ARTICLE VI - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


