ARTICLES OF INCORPORATION

OF

THAI GARDEN, INC.

The undersigned subscriber to the articles of incorporation, Komkrit Taokeaw, who is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I.

Name

The name of this corporation 's THAI GARDEN, INC. The mailing address of the corporation is 4804 S. Tamiami Trail, Sarasota, Florida 34231.

ARTICLE II.

Term of Existence

The date when corporate existence shall commence shall be the date of filing of these articles with the Department of State, and the corporation shall have perpetual existence thereafter.

ARTICLE III.

Nature of Business

This corporation is organized to engage in any and all lawful businesses.

Powers

These articles of incorporation may be amended in the manner provided by law.


