ARTICLES OF INCORPORATION OF MIL'S MAILS AND REAUTY MORES, INC.

I, the undersigned, MILDA V. LOPES, acknowledge and file in the office of the Secretary of the State of Florida, for the purpose of forming a corporation for profit, in accordance with the laws of the State of Florida, this Certificate of Incorporation, as by law provided.

I. MAMEL

The name of this corporation shall be:

MIL'S MAILS AND BEAUTY WORKS, INC.

II. BUSINASS:

The general nature of the business and businesses to be transacted as follows: MAIL SALOW a MASSAGE; and,

To manufacture, buy, sell, trade and deal in all and every kind of material, product, manufactured or unmanufactured; to buy, acquire, hold, use, employ, mortgage, convey, lease and dispose of patent rights, letters patent, processes, devices, inventions, trademarks, formulas, good will and other rights.
