ARTICLES OF INCORPORATION OF S & P WOODWORKS, INC.



The undersigned subscribers to the articles of incorporation, SAM H. SPRUILL and MICHAEL DARROHN, who are natural persons competent to contract, hereby form a corporation under the laws of the State of Florida as follows:

ARTICLE I

Name

Term of Existence
