THIRD: The number of shares the corporation is authorized to issue is: One Million (1,000,000) common shares with no par value.

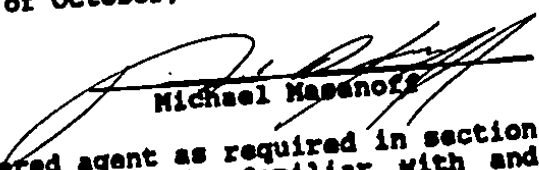
