ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is R & L Inc..

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The general purpose of the corporation is to operate Gas Station, to retail gas, beer and wine, general groceries, and to engage in any lawful act or activity for which a corporation maybe organized under the general corporation law of Florida (GCL), other than the banking business, the trust company business, or the practice of profession permitted to be incorporated by the Florida Corporation Code.

The corporation is authorized to issue only one class of stock and the total number of shares which the corporation is authorized to issue is Five Hundred Thousand Shares at One Dollar (\$1.00) per share. All of the corporation issued shares of capital stock shall be held of record by not more than Thirty-Five (35) persons.

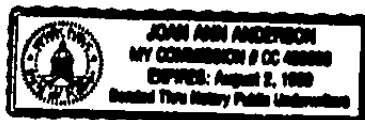
