

ARTICLES OF INCORPORATION OF Krugar Corporation



ARTICLE I Corporate Name

The name of this corporation is: Krugar Corporation.

ARTICLE II Nature Of Business And Powers

The general nature of the business to be transacted by Krugar Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III Capital Stock


