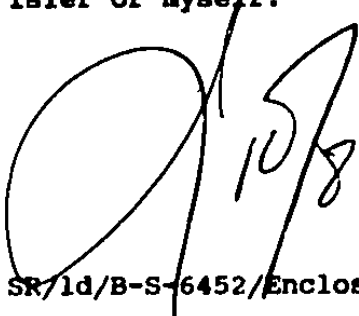

The undersigned incorporator, J. Michael Stewart, hereby forms J. MICHAEL'S DOCKSIDE BAR AND GRILL, INC., a Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be J. MICHAEL'S DOCKSIDE BAR AND GRILL, INC. and its address is 2715-A Redwood Street, Panama City Beach, Florida 32408.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.

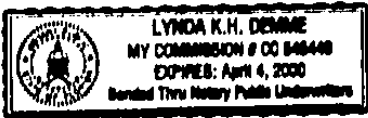
